Samaritan North Lincoln Hospital (SNLH) is a member of Samaritan Health Services (SHS), a regional network of hospitals, physicians and senior care facilities. The network, formed in the late 1990's, serves approximately 290,000 residents in Linn, Benton, Lincoln and portions of Polk and Marion counties in Oregon. It is locally owned, and its boards of directors include hospital leaders, physicians and community representatives. SNLH provides healthcare services regardless of race, color, creed, sex, national origin, disability or age. The mission of SNLH is to enhance community health and achieve high value through quality services across a continuum of care. The collective vision of the SHS system is to be a values-driven organization governed by community members, physicians and other health care providers. SHS seeks to be the first choice of consumers in the region and to lead collaborative efforts among those who share similar goals.

	Program Services Samaritan North Lincoln Hospital (SNLH) has been a part of the fabric of its community, serving the citizens in Lincoln County, since 1967. SNLH includes a critical-access hospital and several medical clinics, with over 350 employees and 100 volunteers providing quality healthcare services to the community. During 2009, SNLH served 1,103 inpatients, had 10,017 emergency department visits, performed 1,475 surgeries, and delivered 181 babies. In addition, SNLH performed 47,227 imaging procedures, had 10,514 home health/hospice visits, and had 21,267 physician clinic visits.

Physician clinics meeting the definition of subsidized health services were included in the reporting for line 7g The portion of net community benefit expense related to these clinics is \$1,785,804

The costing methodology used to calculate the amounts reported in Schedule H, Part I, line 7a and 7b is a cost-to-charge ratio derived using Worksheet 2, Ratio of Patient Care Cost-to-Charges from the Schedule H instructions For line 7g, a combination of the cost-to-charge ratio and cost accounting system calculations is used since not all services are tracked in the cost accounting system

The costing methodology used to calculate bad debt expense (at cost) on line 2 of Part III is based on the facility cost-to-charge ratio, in conjunction with Worksheet A from the Schedule H, Part III instructions Line 3 represents an estimate of the amount of cost included in Line 2 (bad debt expense at cost) that reasonably could be attributable to patients who likely would qualify for financial assistance under the organization's charity care policy, but for whom the organization was not able to obtain sufficient information to make a determination The methodology used to estimate this potential charity care cost is based on financial assistance applications denied due to incomplete documentation, multiplied by the average charity care write-off for approved applications Samaritan North Lincoln Hospital (SNLH) is one of five hospitals of Samaritan Health Services (SHS) As a network, SHS prepares its financial statements on a consolidated basis Footnote 1 (r) from the audited consolidated financial statements entitled "Provision for Uncollectible Accounts" describes bad debt expense as follows "SHS provides for an allowance against patient accounts receivable for amounts that could become uncollectible SHS estimates this allowance based on the aging of accounts receivable, historical collection experience by payor, and other relevant factors There are various factors that can impact the collection trends, such as changes in the economy, which in turn have an impact on unemployment rates and the number of uninsured and underinsured patients, the increased burden of copayments to be made by patients with insurance coverage and business practices related to collection efforts These factors continuously change and can have an impact on collection trends and the estimation process used by SHS "

Total Medicare allowable costs reported on Part III, Section B, line 6 is calculated by utilizing Worksheet B in the Schedule H instructions in conjunction with amounts taken directly from the filing organization's Medicare cost report The cost report includes activity for Medicare fee-for-service patients but not Medicare managed care patients

Samaritan North Lincoln Hospital (SNLH) actively participates in assessing the health care needs of the community SNLH works closely with the Community Health Improvement Partnership (CHIP) Coordinator to conduct a comprehensive needs assessment every few years The CHIP Coordinator facilitates the needs assessment process in alignment with the Oregon Pacific Area Health Education Center (OPAHEC) and several community partners Both quantitative and qualitative data are collected by the Coordinator and OPAHEC staff from county residents to help identify needs and establish priorities for the community This process includes telephone surveys, focus groups, community forums and personal interviews with several community members from throughout Lincoln County

The organization is committed to providing highest quality healthcare services to all, regardless of their ability to pay If qualifications are met, patients' care may be provided free or at a reduced cost The determination is based in part on poverty income guidelines issued by the U S Department of Health and Human Services Once a completed financial questionnaire has been submitted, individuals/families at or below 200 percent of the established Federal Poverty Level (FPL) could be eligible to receive free or discounted care (charity care) The organization informs and educates patients and community members by publishing information regarding all financial assistance options on its website, in addition to in person at the Registration area, and through clearly identified materials located in the Registration area

Samaritan North Lincoln Hospital (SNLH) primarily serves the residents of north Lincoln County Located on a primarily rural portion of Oregon's central coast, Lincoln County is home to 44,700 residents Within Lincoln County, the large tribal population is disproportionately burdened by health inequities There are 4,660 enrolled tribal members of the Confederated Tribes of Siletz Indians, of which 21.6% live in Lincoln County Lincoln County lacks a major metropolitan area and consists of many small communities scattered throughout the region Newport is the county seat and has a population of 10,600 Lincoln City is the second largest town and has a population of 7,930 The median income for Lincoln County is \$50,000, with 16.8% living below the federal poverty level Thirty-eight percent of the population lives in rural unincorporated areas and 14.7% of residents are uninsured Samaritan Pacific Communities Hospital, located in Newport, is a sister hospital in southern Lincoln County serving local residents Lincoln County is designated as Medically Underserved Population and the Migrant Seasonal Farmworker population has been designated a Primary Medical Care Health Provider Shortage Area by the Health Resources and Services Administration The Siletz Community Health Clinic, which serves the 3,666-acre reservation of the Confederated Tribes of Siletz Indians, is a designated Health Provider Shortage Area

SNLH provides services and activities that are classified as community building SNLH is committed to providing support services to the most vulnerable residents in the community This is demonstrated through the ongoing support to the Samaritan Early Learning Center (SELC) The SELC offers low-cost infant/toddler care to families in Lincoln County and is the only facility in north Lincoln County to offer this service SNLH also leads disaster preparedness drills with local agencies and staff participation in support services for homeless families in the community SNLH staff serve on many local coalitions and boards that promote the health of the community Board affiliation includes, but is not limited to, Lincoln County Economic Development Council, Joint Transportation Committee, Project Homeless Connect, and local civic organizations The SNLH staff conduct recruitment activities to encourage physicians and other medical professionals to provide services in rural Lincoln County

SNLH's governing board is comprised of local-area residents and officers of affiliated organizations The majority of the board members are independent, meaning they and their family members are not employees of SNLH nor do they have significant business relationships with SNLH SNLH extends its medical staff privileges to all qualified physicians in the community SNLH applies surplus funds to improve patient care, medical education and research SNLH invests in updating equipment, technology and facilities to improve patient care SNLH is accredited for continuing medical education and offers frequent programs for area physicians and other health professionals The Center for Health Research and Quality, a department of SNLH's parent company, Samaritan Health Services (SHS), provides administrative oversight for health and clinical research, quality improvement projects and studies, and other sponsored activities for SNLH and its affiliated hospitals SNLH also provides scholarships for students and employees in health occupations and contributes financially to the Oregon Coast Community College

"Building Healthier Communities Together" is the commitment of, and the motivation for, Samaritan Health Services (SHS), a network of Oregon hospitals, physicians, and senior care facilities that serves the health care needs of people in the mid-Willamette Valley and the Central Oregon Coast As the individual entities of SHS came together to build healthier communities, they were drawn by a shared mission "to enhance community health and achieve high value through quality services across the continuum of care." That means SHS looks carefully at local health care needs, and it gives thoughtful consideration to the most effective ways to meet those needs The result is a rich mix of local and centralized regional services which provide high value and excellent healthcare for people at all stages of their lives Services are provided to all individuals, regardless of their ability to pay The collective vision of SHS is to successfully operate as a values-driven, church-related organization governed by a partnership of community members, physicians and other health care providers SHS seeks to lead collaborative efforts among providers, employers, health plans and consumers who share similar goals and values to meet the challenges of the future Samaritan North Lincoln Hospital is one of two Critical Access Hospitals of SHS primarily serving residents of north Lincoln County Other affiliated hospitals are Good Samaritan Hospital serving residents of Benton County, Samaritan Albany General Hospital and Samaritan Lebanon Community Hospital, serving residents of Linn County, and Samaritan Pacific Communities Hospital, serving residents of south Lincoln County
