Environmental Health ProgramThe San Joaquin Valley Air Pollution Control District Board (SJVADB) was the subject of an action in June by the Center for Race, Poverty and the Environment, LUCA, and Metro staff following comments by a member of the Board, which singled out Metro EH Director for personal and unprofessional criticism. The appointee, from the Merced Board of Supervisors, in a public meeting, referred to the Director as one of those folks he tunes out because he doesn't think they tell the truth. The action consisted of a march from the SJVADB offices along Gettysburg to Blackstone, a rally at the corner, a return march to the SJVADB offices with a rally in front, and speakers addressing the Board calling for the Board Member's removal. An additional action occurred simultaneously at the SJVADB Bakersfield office where additional speakers called for the Member's removal through teleconferencing. State Senator Dean Florez directed a letter to the Member stating "However, when board members, in their official capacity, single out members of the public for particular ire and challenge their integrity, such conduct unfortunately creates an unwarranted level of hostility damaging to the concept of transparent government and public participation." EH collaborated with the environmental community on state legislation to require the Department of Pesticide Regulations (DPR) to return to the goal of a 20% reduction in Volatile Organic Compounds (VOC) instead of the 12% they currently had set. VOCs are smog forming acids in the atmosphere. While the adopted plan called for a 20% reduction, DPR decided to roll-back the goal to 12%. Following a lawsuit, which they lost, and an appeal, which they won, without legislation the reductions will only attain the lower level. In November, EH hosted the San Joaquin Valley Cumulative Health Impacts Project (SJV CHIP) as the group reached an important milestone. EH is the lead organization for the collaborative on this project. The Center for the Study of Regional Change at UC Davis presented the initial Environmental Justice Maps that they had been collaborating with SJV CHIP to create. These maps are the core of the SJV CHIP campaign plan which was finalized in December. They document the location of pollution sources with relation to areas of social vulnerability based on poverty levels, linguistic isolation and percentages of people of color. In December, the EH Director spoke to the California Air Resources Board (CARB) as one of only two San Joaquin Valley community representatives. The Board was considering taking a huge step backwards by repealing the Diesel Truck Rule that was passed in December 2008. Due to the state of the economy, there was a lot of pressure from the trucking industry to delay implementation of the Rule. CARB staff reported that while the economic downturn has affected the amount of emissions created by diesel trucks this year (by 10 - 18% compared to 2007), as there is less trade, and, therefore, less goods movement, the effects are not great enough to meet our clean air targets. Diesel trucks remain by far the largest source of smog and particle pollution in our air basin. We will never reach federal clean air standards without cleaning them up. The EH Dirdirector was quoted in the Fresno Bee and her comments were received by the Board, which voted not to repeal the Rule, but to do further research on the matter. CARB will be examining options to delay requirements for some sectors of the industry due to the reduced activity and will make a decision at a later date. (See continuation)

Central California Regional Obesity Prevention Project (CCROPP)CCROP Program was cited for its contribution to the collaborative effort that resulted in the elimination of "diaper bags" from four area hospitals and the substitution of bags containing breastfeeding information, infant and childcare information, and more. The "diaper bags" are seen as a significant obstacle to breastfeeding efforts as they contain processed food products for infants such as powdered formulae. Breastfeeding has been demonstrated to contribute to a strengthened immune system, the reduction of childhood obesity, and improved psychosocial development among other positive aspects. In February CCROPP, in collaboration with the HN Program, convened a Farmers' Market Summit. Approximately 120 persons were in attendance to hear speakers present on need, resources, requirements, obstacles, desires, and the city's future plans. Representatives from the Agricultural Commissioner's office, U C Cooperative Extension, the Planning Department, various farms, and market managers were present. Discussions also included the development of a farmers' market association. UCSF has linked with CCROPP to provide their fourth year medical students enrolled in a Migrant and Farm Work Health class with an opportunity to discuss with CCROPP staff some of the issues and challenges facing the delivery of health care to those populations. CCROPP held a School Wellness and Training Forum in March. The Training was designed to increase awareness of the School Wellness Policy among teachers, school administrators, and parents. The Policy was adopted more than two years ago, however, since then implementation has been lackluster. This Forum kicked-off CCROPP's initiative to better implement the policy throughout all levels of the school District. The CCROPP Director was accepted on a full scholarship at the Central Valley Health Policy Institute's Health Leadership Training. This is a yearlong commitment requiring a full day classroom attendance monthly, a significant reading requirement, and the selection and completion of a project by year's end. The HN Program and CCROPP were selected to work with the U S Department of Agriculture and the school district for the development of a pilot program for a children's universal breakfast program (universal = all children). The pilot project, one of 12 nationally, will test the feasibility and effectiveness of a variety of approaches - breakfast in the classroom, "grab-and-go" from carts between classes, and even breakfast on the bus.

Hunger / Nutrition ProgramIn May's "Hunger Action Day", more than 40 low income residents, speaking five different languages, boarded buses at 6 a.m. to travel to Sacramento to meet with local state legislators to tell them the stories of hunger in their neighborhoods and in their families. Recently trained in advocacy, for many, this was their first trip to Sacramento. Carrying a packet of information and, as a symbol of existing need, participants left an empty grocery bag with each legislator with a sign on the side that said "If I Had Food For My Family It Would Be In This BAG!", the residents engaged in "straight" talk with legislators and their staff. In addition to telling their own family story, they asked for support for healthy nutrition at schools and child care centers and a simpler food stamp application process, among other matters. A first time experience for many of the participants, on the bus trip home they spoke of feeling empowered and of ongoing activism, they spoke of government's role in making the lives of their families and neighborhoods better, and they spoke in terms of "we want " and "we need ". And 50 more activists were born!The Outreach Coordinator for the Hunger/Nutrition Program, received a statewide Hunger Fighter Award in Sacramento on the steps of the capitol as part of the Hunger Action Day activities. The award was presented by the California Hunger Action Coalition (CHAC) for her leadership in anti-hunger work especially with low income and multi-lingual, multi-ethnic people in Fresno County. The Coordinator has led efforts to provide nutrition education, food stamp outreach, and promotion of the Summer Lunch Program in Fresno County. Through her efforts the Food Resource Hotline (1-800-870-3663) has up-to-date links to food stamps, WIC, Food Pantries, and Summer Lunch sites that connected low income families to healthy food. She also worked with English as a Second Language students at Neighborhood Resource Centers and Cesar Chavez Adult School, and the Refugee Forum. This is the third year in which she has recruited and trained more than 40 people to travel to Sacramento to talk with their legislators about their need for healthy food for their families. In February, the Program, in collaboration with CCROPP (see below) convened a Community Gardens Summit. More than 150 people attended the evening event to hear local panelists outline their experience with gardens in the Fresno area. The Fresno Parks and Recreation Department Director announced the development of a series of gardens at Park sites and that they would be working with the Program to develop and manage them. A second gathering of the Community Gardens Coalition took place in mid-June with approximately 70 in attendance. A primary focus of the gathering was to begin work on a draft city ordinance to make the process of locating and securing a city permit for gardens simpler and easier. The Coalition continues its work in identifying garden locations around the city and the development of the documents needed to site and manage gardens. The Program was the successful candidate in response to the City of Fresno Parks Department RFP for a Garden Manager for the gardens which will be located on parkland throughout the city. The first garden was opened in the fall with 100 individual garden plots available for use. Two school farm stands were opened in June, one at an elementary school and the second at a middle school. The School Farmstand model is a response to the 2009 Fresno City Ordinance on farmer's markets, developed with significant leadership by the Program which now allows farmer's markets in residential neighborhoods. A third Farmstand is under development for another middle school. The Program continued to sponsor an 800 call center, operating 24 hours a day/seven days per week which provides local information in multiple languages on where to apply for food stamps, pantry locations by zip code, WIC locations, and Summer Lunch Sites also by zip code. Form 990, Part III, Line 4d	Form 990, Part III, Line 4d Other Program Services Description	OTHER PROGRAM SERVICES 4 Health Care Access and OtherHealth Care Access (HCA)- The Coalition for Patient Care (CPC) held an educational forum for individuals and families who may be eligible for health care services through the Medically Indigent Services Program (MISP) MISP is a program offering free or low-cost health care services to eligible low-income individuals and families The State of California requires all counties to provide MISP In Fresno County that service is provided through the Community Medical Centers hospital The forum was held at the Keenan Center, in Huron, in August The forum provided information on eligibility, application requirements, and how to file a complaint in the event of denial or inadequate service CPC, a coalition of more than 15 community organizations with Metro as a lead organization, seeks to ensure that all members of our culturally, socially and linguistically diverse community receive the highest level of physical and mental health care, regardless of economic standing The Coalition has been working with the Board of Supervisors and the Public Health Department to improve access to MISP and improve the level of health care services provided through the Program A second forum was held in South Fresno in August At the last meeting of the Local Health Care Coalition it was decided that the Coalition will no longer continue to meet For more than a year the Coalition struggled with its purpose for existing and found it increasingly difficult to identify its role in the community and the resources it could bring to that role This decision was based in part on the work of the CPC which is ongoing While originally instrumental as advocates on a variety of health care issues since 1997, the Coalition had taken on fewer issues over the last few years and primarily limited itself to an advisory group for the now defunct Community Health Care Roundtable Metro (Organizational Level)- The California Endowment (TCE), one of our major funding sources, underwent a strategic planning process and developed a 10-year vision focusing on 14 "places" throughout the state as the primary recipients of their funding for the next 10 years, Central/West Fresno is among the 14 As a first step, they required that community organizations collaborate on the development and submission of a Planning Proposal detailing how we would approach the development of a 10-year plan Metro developed, published, and distributed 4,500 community resource directories, containing contact information and a summary description of the services provided by more than 350 organization and service providers, to individuals, health care organizations, community based organizations, information and referral services, city and county elected officials, schools (grade, high, community college, and university), law enforcement organizations (police, sheriff, district attorney, parole agents, and adult and juvenile jail personnel), and religious institutions Metro developed and published a spring and fall newsletter which was distributed to over 4,600 individuals, organizations, congregations, institutions, and governmental agencies Each newsletter contained articles related to Environmental Health, Hunger and Nutrition, Obesity Prevention, and Health Care Access All of Metro's programs have had ample media opportunities to highlight their work Staff frequently interview or take on the task of coordinating interviews such as the one with a reporter from the Economist Magazine whose interest was to learn more about changes in urban Latino families Fresno was chosen by the Economist because the area has a high teenage pregnancy rate and provides clues to the future of Hispanic America Additional media opportunities included Fresno Bee interviews on a number of health related issuesFresno Bee article on minority women at risk of poor healthRadio Bilingue Interview on "La Cultura Cura - Local Foods Campaign"Public Media Center training on how to be a better spokesperson(See continuation)
