Media and Communications - The ARC Media program publishes various platforms for challenging points-of-view and improving the breadth and depth of media coverage on racial justice issues across the nation. Our publication, ColorLines, currently in its 12th year of publication, reads between the lines to provide sharp political analysis, provocative explorations of popular culture and insightful coverage of social change efforts. ARC has continued to expand our mobilization capacity with articles, blogs and multimedia presentations now available on our web sites: arc.org, colorlines.com and racewire.org.

Network: Racial Justice Leadership Action - The Racial Justice Leadership Institute (RJLI) combines leadership development and education with strategic planning that focuses on advancing racial justice. In 2009 the work of the RJLI included direct, hands-on training with more than 68 organizations across the United States, working with policy makers, activists, thinkers, educators, writers, and artists. The RJLI program coordinates ARC's national conference, called Facing Race and leads ARC's public policy work to illuminate the ways in which public policy can be shaped to address systemic and institutional inequities. In 2009, we released the Racial Justice Legislative Report Cards in California, Illinois, and Minnesota as well as new states Nevada, Colorado, Washington and Idaho.

Strategic Research produces reports and policy analysis to focus on equitable outcomes in communities of color. Through these efforts ARC produces reliable, relevant, and accessible research that constructs the analytical foundation for racial justice efforts across the nation and supports other ARC programs. In 2009, we released reports and toolkits on Green Economies, two reports titled Check the Color Line Income Report and Race and Recession Report, focused on the relationship between racial inequity and the current recession, and Underprotected, Undersupported: Low-Income Children at Risk a report exploring the effects of unlicensed care on the quality and safety of childcare available to low-income families.
