Other Program Services

Advocacy

Working with Lambda Legal, the National Coalition for LGBT Health, the Human Rights Campaign, GLAAD, National Gay and Lesbian Task Force and other organizations, GLMA advocates for increased public and private resources for LGBT health. We also respond to frequent requests from the media. Issues addressed in 2009 included raising awareness about the need for developing LGBT inclusive policy in healthcare settings (such as hospitals), advocating for health reform measures that would address healthcare disparities of the LGBT community, and the FDA's ban on blood donations from gay and bisexual men.

Healthcare Equality Index

In 2009, GLMA and the Human Rights Campaign Foundation released the 3rd annual Healthcare Equality Index, which addresses patient non-discrimination, visitation, medical decision-making, cultural competency training for staff, and employment policies. Released May 2009, the 2009 Healthcare Equality Index rated 166 U.S. healthcare facilities on their policies and practices related to the LGBT community. In 2009, 10 facilities reported LGBT-inclusive policies and practices for all of the 10 HEI rated criteria.

Online Education Programs

In 2009, GLMA launched its first online Continuing Medical Education (CME) program to train physicians and other healthcare professionals on LGBT health issues. The online course was developed using a grant of \$150,000 from the American Legacy Foundation to train physicians and other healthcare professionals on how to get LGBT patients to stop smoking. The grant also supports advocacy efforts aimed at ensuring

that tobacco control organizations address the needs of LGBT patients. Additional courses will be launched in 2010, including a Bristol-Myers Squibb funded "HIV/AIDS Issues for the LGBT Community," and a California Endowment funded "LGBT Healthcare 101."

AMA/GLMA Survey of US Physicians on LGBT Healthcare Needs

In 2009, GLMA and the American Medical Association (AMA) continued work on a joint project to study physicians' attitudes, knowledge and beliefs about LGBT patients' unique health care needs. The AMA is supporting this project with a \$100,000 grant to GLMA to conduct two national surveys. In 2008, GLMA and AMA staff conducted an extensive literature review and finalized the survey instrument. The first survey was conducted in the spring of 2008, and investigated the experiences of LGBT physicians and their perceptions of discrimination against LGBT patients and healthcare professionals. A second survey, was mailed to a randomly selected sample of U.S. physicians who specialize family practice, internal medicine, adolescent medicine, obstetrics and gynecology, and psychiatry in the fall of 2008. This survey will investigate physician experiences, practices, attitudes and training related to their LGBT patients and colleagues. Analysis of these surveys will be finalized in 2010.

Lesbian Health Fund

One of GLMA's most important programs is the Lesbian Health Fund (LHF), which makes direct grants to fund lesbian health research, the world's only fund solely dedicated to the unique health needs of lesbians. In 2009, LHF awarded grants totaling more than \$65,000 to projects for lesbian health research. Recent areas of research include alternative insemination in sexual minority women, social exclusion

and postpartum depression among lesbian/bisexual mothers, romantic relationships and eating-related behaviors, the measurement of overweight and obesity, and using a social cognitive model of identity development to examine risk behavior in LGBT adolescents. Since its founding in 1992, LHF has provided more than \$616,000 in funding for this important research. LHF grantees have gone on to secure over \$10 million in funding from a variety of sources for follow-on studies, made possible because of findings from their LHF-funded research.

Provider Directory

An important aspect of GLMA's work is to connect members of the LGBT community with culturally competent health care providers. Discrimination in health care settings and barriers to insurance coverage for members of the LGBT community continue to discourage regular visits to a primary care providers, and often inhibit the quality of information sharing necessary between patients and providers. In some areas of the country, it can be very difficult to find an LGBT friendly therapist, a fertility clinic who will work with same-sex couples, or providers with HIV/AIDS care training. In 2008 GLMA made technology investments to expand provider directory, which was in created in 2001. During 2009, the number of providers listed in the online directory increased 70%, from 706 to 1205. On average, in 2009, more than 3,000 unique users visit the online provider directory each month. GLMA staff also provides live assistance to those without internet access.
