CAFF's Biological Agriculture Program works with farmers to pursue
innovative soil and pest management initiatives, while promoting
sustainable farming practices. In 2009, the program held an annual
cotton farm tour and nine project field days, which attracted more than
550 growers, pest control advisers, agricultural professionals,
researchers, educators, students and apparel and textile industry
representatives. In addition, nineteen growers demonstrated water
quality protection practices on 839 acres of tree crops, successfully
showing other farmers how to reduce pesticide pollution near
environmentally sensitive waterways. CAFF also helped to plant 352
acres of self-reseeding cover crops to show local farmers techniques
that boost soil nutrients and dramatically reduce pesticide run-off.

CAFF's Farm to School Initiative has two complimentary elements that
connect school cafeterias and classrooms with local agriculture-while
students learn about local agriculture, fresh, locally grown produce
appears on the school menu. The program educates students and school
communities about sustainable family farms and adds value to family
farming operations by training growers to host educational programs
that connect them with their communities and generate revenue. CAFF
contracts with local school districts to implement the Know Your Farmer
Program, an effort that reached 13,500 students in 2009 by bringing
farmers into the classroom and children to the farm. In addition, the
Watsonville True Farmer Invasion Program connected 250 students with
local farmers and helped them grow hundreds of pounds of produce to
