Other salaries and wages in the amount of \$1,887,832 were paid to faculty, full-time and part-time instructors, faculty aides, and administrative staff The faculty, instructors, and faculty aides have had active careers in high technology industries, computer programming, and businesses, have had current industry experience, and were equipped with up-to-date knowledge and skills in their teaching subjects Administrative staff provided administrative services to NPU future and current students and alumni The faculty, instructors, faculty aides, and administrative staff provided programs available to the students, conducted effective business practices, and adopted teaching methods and environments where conducive to the development of graduates in undergraduate, graduate, and doctorate programs with critical thinking skills as well as competence in the subject area Theses expenses partly generated tuition revenues in the amount of \$10,055,888 in 2009

These other program services prepared students for the practice of engineering, computer science, and business at a professional level The NPU nurtured that, in addition to the depth of specialization, all students must have some knowledge, understanding, and awareness of real life practices Therefore, NPU provided work study to enable students who participated to gain real life experience in their subject matters In addition, NPU equipped faculty members with up-to-date knowledge and skills in their teaching subjects with professional trainings and seminars Also, these other program services were to keep up to date the facility support in hardware, software, and instructional supplies and equipment inside and outside the classrooms to meet industry standards Furthermore, these other expenses included the depreciation expenses for the classrooms and other facilities that served the students, such as cafeteria Further, these other expenses also enable the NPU to provide services, such as academic and non-academic counseling, career placement services, and student association's activities throughout the year

These expenses included university rental housing expenses and facility rental expenses in the amount of \$577,848 which most part generated dormitory revenue in the amount of \$320,016 in 2009 The dormitory was available for Northwestern Polytechnic University’s students only The students who lived in the dorm were diverse ranging from domestic students from all over the United States to international students The university housing helped the transition of living for most students who just moved into the area The university housing provided a new environment with new people, decisions and responsibilities In addition, the university housing helped the students to better enable to take full advantage of all the resources the University had to offer They have a wonderful opportunity to learn more about themselves, others, and the community The rest of these occupancy expenses were for maintaining the classrooms and providing communication and utilities for teaching purposes
