Media Services - The Organization's media and educational divisions consist of three nationally broadcast radio shows that are currently aired on major radio stations in the United States of America and Canada The Jay Sekulow "Live" program is a 30 minute daily call-in radio program and is heard on over 738 outlets nationwide The Jay Sekulow Weekend Edition is also a 30 minute program and it is broadcast across over 350 outlets nationwide The third program "Law and Justice Journal" is a short 1 minute segment that is carried by over 654 radio stations The purpose of all three radio programs is to educate the public on the mission of the Organization and educate the public During 2009, the organization also produced two weekly television programs The ACLJ weekly show is aired on 30 minute time slots on the Tnnity Broadcasting Network(TBN), FamilyNet, NRB, Daystar, Inspiration Channel and other networks The Organization also operates a youth outreach TV program, The Logan Show, which is seen on religious networks including TBN, FamilyNet, Inspiration Channel, and other networks The Logan show ceased production in February 2009
