AFTER THE YOUNG PERSON LEAVES THE HOSPITAL, THE INTERVENTION SPECIALIST CONTINUES TO FOSTER A RELATIONSHIP, EASING THE YOUTH'S TRANSITION BACK INTO THE COMMUNITY THROUGH PERSONAL AND TELEPHONE FOLLOW-UP CONTACT. THE SPECIALIST PROVIDES SUPPORT AND MENTORING TO THE YOUTH, AS WELL AS TO HIS/HER FAMILY, THROUGH INTENSIVE CASE MANAGEMENT FOR A PERIOD OF TYPICALLY SIX-MONTHS TO ONE YEAR. THE INTERVENTION SPECIALIST COORDINATES ASSISTANCE FROM SOCIAL SERVICE PROVIDERS; PROBATION OFFICERS; SCHOOL TEACHERS, ADMINISTRATORS, AND GUIDANCE COUNSELORS; HOSPITAL MEDICAL SOCIAL WORKERS; AND OTHER YOUTH SERVICE PROFESSIONALS.
