Campaigns - International Rivers helped establish the "Save the Mekong" coalition to stop a series of dams planned for the Lower Mekong. The coalition hand-delivered a petition, with 16,000 signatures, to the Thai Prime Minister calling for the river to remain free-flowing. Our analysis and advocacy concerning the serious flaws with carbon offsetting continued to bear fruit. The executive board of the Kyoto Protocol's offsetting mechanism tightened its project approval procedures making it difficult for the most egregious projects to get permission to sell credits. We submitted a claim to the investigations unit of the African Development Bank, showing how the Gibe 3 Dam in Ethiopia did not comply with the bank's safeguard policies. They accepted our claim and have opened an investigation. We staged a protest at Home Depot's AGM in Atlanta, calling for the home improvement giant to stop purchasing timber from companies involved in plans to build a series of dams in Chilean Patagonia. We coordinated the International National Day of Action Against Dams, this year with more than 110 actions in 26 countries.

Information and media - International Rivers helped a Mozambican NGO produce a major report on clean energy options for the country. We greatly increased our output of blogs and several staff began blogging for the Huffington Post, one of the web's most visited sites. We started a Chinese language newsletter "World Rivers Bulletin" for distribution to Chinese NGOs and journalists and academics.
