Amendments to the Articles of Incorporation. Changed the requirements for amending the Bylaws to require a vote of the Board of Directors as well as the members of the corporation entitled to vote (the "Members").

Amendments to the Bylaws: (1) Revised the list of the Planned Parenthood affiliates who are the Members to reflect the effect of two mergers involving two Washington State Planned Parenthood affiliates; (2) amended the voting rights of the Members so that each Member has one vote; (3) clarified that Members must designate an

authorized representative to attend meetings and vote on behalf of the Member; (4) revised the composition of the Board of Directors to consist of representatives appointed by the Members, called "affiliate directors," and up to nine at large members to be nominated by the Board of Directors and approved by the Member covering the territory in which the candidate resides and provided that at large directors have term limits of two terms of three years each; (5) added a provision that permits an affiliate director to be removed for any reason by the Member that appointed such director and an at large director to be removed with or without cause by the Board upon a vote of a majority of the directors in office at a meeting at which a quorum is present; (6) amended the procedures for filling a vacancy by providing that a vacancy in an affiliate director position shall be filled by the Member who selected such affiliate director and that a vacancy in an at large director position shall be filled by the Board, with the approval of the Member covering the territory in which such proposed director resides; (7) added the following duties to the duties of the Secretary: see that all notices are duly given in accordance with the provisions of the Bylaws or as required by law; oversee the keeping of the corporate records of the corporation; keep or cause to be kept records of the post office and email addresses and class, if applicable, of each member and director and of the name and post office and email address of each officer; (8) clarified that the chief executive officer of the corporation is an ex officio, nonvoting member of the Board of Directors; (9) amended the requirements for amending the Bylaws to require a vote of the Board of Directors as well as the Members.
