THESE POSTERS CONVEYED A COUPLE OF DIFFERENT MESSAGES: DISCOURAGED ADULTS FROM BUYING/PROVIDING ALCOHOL TO MINORS AND PROUDLY STATING THAT THIS RETAILER DOES NOT PROVIDE ALCOHOL TO MINORS.
