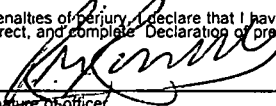

(Revenue \$)Promotion of grant making for social change by facilitating the grant-making process for donors who wish to make grants to organizations whose work deals with social change. Common Counsel Foundation suffered the loss of these payroll tax dollars, plus late filing penalties from the IRS. This loss was offset by a partial credit to their account by First Priority Payroll. The total estimated loss was \$7,600.
