Power in Asians Organizing - 1) Conducted several Chinatown experiments to demonstrate how rising interest around climate change and work to reduce greenhouse gases can contribute to economic and environmental justice in low-income immigrant communities. 2) Worked with 5-8 state and local partners to design and measure the impact of two municipal experiments. 3) Actively engaged in local development and land use decision making processes to develop a model for how communities can move from being pollution-based to being model green communities that mitigate against climate change while ensuring the equitable spread of economic and political benefits.

Laotian Organizing Project - In Richmond, more than a dozen of APEN's LOP leaders participated in trainings and worked with other community-based organizations to develop recommendations and draft language to be incorporated into the General Plan. Our coalition actively met with decision-makers alongside several planning commission and city council meetings over the year. There have been several delays in the City's General Plan timeline, so APEN has continued to monitor its progress.
