The Taylor Family Foundation provides approximately 2,800 Northern California children living with life-threatening and chronic illnesses, developmental disabilities and those who come from an at-risk community a free and nurturing camp experience. The Taylor Family Foundation offers a fully-staffed facility with specialized food services and programmatic support to enable each camper with the opportunity to gain independence, build self-confidence and become more optimistic and hopeful about their life-circumstances. Throughout its 20 years of operation, TTFF has helped more than 40,000 children and 70,000 parents.

The Taylor Family Foundation also extends its mission of preserving the wellness of children in Northern California with life-threatening and chronic illnesses, disabilities and youth at risk by providing funding to families through an Urgent Need Fund (up to \$5K) and grants to other 501(c)3 non-profits (Up to \$50K). This funding supports camper families in need. Specifically, this fund helps with the basic necessities that these families may need and cannot afford. Expenses have included eye exams, travel to and from the hospital and funeral expenses. The grant assistance helps to fund programs that aligned themselves with our mission of supporting children with "orphan illnesses" or ones that receive very little or no state or federal funding.
