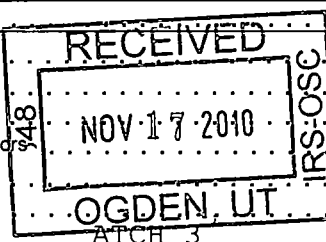



(4) TO PROVIDE PROGRAMS THROUGH HAWAII WINTER BASEBALL WHICH BUILD HEALTH, EDUCATION AND WELFARE AMONGST HAWAII'S CHILDREN. THIS INVOLVES FUNDRAISING AND COORDINATION BETWEEN (A) HAWAII WINTER BASEBALL COACHES AND PROFESSIONAL BALLPLAYERS AND (B) SCHOOLS AND COMMUNITY GROUPS.
