PCH is advancing the previously developed and prototyped BGP routing integrity check and prefix list filter generation tool to full production status. PCH seeks to make the previously completed tool publically available at a level of performance that will support production use. Also, PCH intends to add a few new features that weren't specified in the original work plan.

4b (Code) (Expenses \$ 279,507 including grants of \$) (Revenue \$)
Voice over Internet Protocol Network Security. PCH proposes to advance the utility of voice-over-IP (VoIP) in the construction of command and control networks for coordination of global critical infrastructure security and management, in both the specific case of INOC-DBA and for general application. PCH conducts research on issues faced by INOC-DBA as it evolves toward a critical command and control infrastructure tool and to undertake development of some core services to address already recognized needs. The tasks include strong cryptographic authentication of the system's users; high availability of the communication services; examination of the systems metadata for situational awareness & integration of the system with other communications services and technologies.

Routing Topology & Network Reliability Dataset Project - PCH assists the Dept of Homeland Security in regularizing the publication of its existing Internet Routing Topology Archive, a large-scale BGP route dataset produced by global network of data collection nodes which we've been deploying since 1994 and by applying instrumentation to our INOC-DBA infrastructure protection hotline system enabling its rapidly growing collection of end-user telephony devices to perform end-to-end loss, latency & jitter measurements between thousands of critical sites across the commodity internet.
