



**ADDENDUM TO ARTICLES OF INCORPORATION OF
NATIONAL WILD HORSE MONUMENT FOUNDATION**

I, a natural person, of the age of eighteen (18) years or more, acting as the incorporator of a corporation under Chapter 82 of the Nevada Revised Statute (as amended from time to time and together with any successor laws, the "NRS"), do hereby adopt the following addendum to the Articles of Incorporation for National Wild Horse Monument Foundation (the "Corporation"):

ARTICLE A

(b) to receive, maintain and invest personal or real property and use the income and principal thereof for exclusively charitable purposes; and

(c) to perform such other functions as may be necessary or appropriate to fulfill the purposes of the Corporation.

The Corporation is organized and to be operated for exclusively charitable and educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, as amended, and future corresponding revenue laws of the United States (the "Code").

The broadest discretion is vested in and conferred upon the Board of Directors for the accomplishment of these purposes, provided, however, that no contributions shall be made or distributed to or for any person, firm, corporation, or other entity that shall apply, directly or indirectly, such contributed funds for any purpose or purposes in violation of the Constitution and statutes of the United States or the State of Nevada.

ARTICLE B

The number of directors constituting the entire Board of Directors shall never be less than one. After the election of the initial directors, the number of directors of the Corporation shall be fixed in accordance with the Corporation's Bylaws (the "Bylaws").

ARTICLE C

Regardless of any other provisions of these Articles of Incorporation or the laws of the State of Nevada, the Corporation shall not:

(1) permit any part of the net earnings of the Corporation to inure to the benefit of any private individual (except that reasonable compensation may be paid for personal services rendered to or for the Corporation affecting one or more of its purposes);

(2) devote more than an insubstantial part of its activities to attempting to influence legislation by propaganda or otherwise; or

- (3) participate in, or intervene in (including the publication or distribution of statements), any political campaign on behalf of any candidate for public office.

ARTICLE D

The Corporation shall have no members.

ARTICLE E

Pursuant to section 82.461 of the NRS, after all liabilities and obligations of the Corporation in the process of winding up are paid, satisfied and discharged, the property of the Corporation shall be applied and distributed as follows:

- (1) property held by the Corporation on a condition requiring return, transfer, or conveyance because of the winding up or termination shall be returned, transferred, or conveyed in accordance with that requirement; and
- (2) the remaining properties of the Corporation shall be distributed to the Bureau of Land Management for the United States, or any such successor department or bureau in the United States. The amount of any distribution made under this ARTICLE E shall be determined by the Board of Directors.

ARTICLE F

A director of the Corporation shall not be liable to the Corporation for monetary damages for any act or omission in the director's capacity as a director, except that this ARTICLE F does not eliminate or limit the liability of a director for:

- (1) a breach of a director's duty of loyalty to the Corporation;
- (2) an act or omission not in good faith that (i) constitutes a breach of duty of the director to the Corporation or (ii) involves intentional misconduct or a knowing violation of law; or
- (3) an act or omission for which the liability of a director is expressly provided by an applicable statute.

If it is determined that the law of the State of Nevada (including without limitation the NRS) authorizes, or if such law is amended to authorize, action further eliminating or limiting the personal liability of directors, then the liability of a director of the Corporation shall be eliminated or limited by this ARTICLE F (without the need of any formal amendment), to the fullest extent permitted by such statutes as so amended. Any repeal or amendment of such statutes or of the foregoing paragraph shall be prospective only and shall not adversely affect any right of protection of a director of the Corporation existing at the time of such repeal or modification.

ARTICLE G

The Corporation may indemnify a person who was, is, or is threatened to be made a named defendant or respondent in litigation or other proceedings because the person is or was a director or other person related to the Corporation, to the extent provided by Chapter 78 of the NRS. The Board of Directors shall have the power in the Bylaws to define the requirements and limitations for the Corporation to indemnify directors, officers, or others related to the Corporation.

ARTICLE H

With respect to any action (i) which is required by the NRS to be taken at a meeting of the Board of Directors or (ii) which may be taken at a meeting of the Board of Directors or any committee established by the Board of Directors, such action may be taken without any such meeting if a written consent setting forth the action to be taken is signed by a sufficient number of members of the Board of Directors or committee thereof as would be necessary to take the action at a meeting at which all, and not just a quorum, of the members of the Board of Directors or members of the committee were present and voted.

ARTICLE I

These Articles of Incorporation and any addendum to such Articles of Incorporation becomes effective when the documents are filed by the Secretary of State.

ARTICLE J

These Articles of Incorporation may be amended by majority vote of the Board of Directors at any annual, regular or special meeting, provided that the notice for any special meeting of the Board of Directors at which amendments to these Articles of Incorporation will be considered includes a description of the amendments to be considered.
