The primary purpose of the Friends of The Davis Public Library is to raise funds from the sale of used, donated books ad magazines. The bulk of our revenues are granted to the library for the purchase or rental of books and audio-visual material to augment the circulating and reference collections. We also sponsor workshops and family programs designed to stimulate reading and writing in the Davis community.

In the calendar year of 2009, the Friends completed the following major support activities for the Davis Branch of the Yolo County Library:

Presented the library with checks totaling \$16,317. for the purchase of books and audio-visual materials for the circulating and reference collections.

Funded the Baker-Taylor book lease program for the year 2010 at a total cost of \$8,868. This program allows the library to lease multiple copies of popular books.

Funded children's, young adult and family programs along with student workshops. Our funding total \$1,198.

Granted the Branch Librarian \$100. Per month to cover incidental library expenses, plus \$500 for a celebration of the opening of a temporary library site. Total \$1,700.

Spent \$622. on book mending.

Funded the New York Times for daily delivery to the library at a cost of \$744.
