The Legal Aid Foundation of Los Angeles (LAFLA) is the frontline law firm for low-income people in Los Angeles. LAFLA is committed to promoting access to justice, strengthening communities, fighting discrimination, and effecting systemic change through representation,

Housing and Eviction Defense: Advocates prepared tenants being unfairly evicted to represent themselves in court and provided legal representation to help clients retain their residency or get relocation benefits and move to better quarters. Advocates also focused on improving the conditions of housing for low-income people by pursuing litigation to get substandard buildings repaired and collaborating with city and state efforts to rehabilitate slum housing, improve code enforcement, and increase the availability of low-cost housing. This program served 31,304 clients in 260 days.

4b (Code:) (Expenses \$ 2,098,250. including grants of \$) (Revenue \$ 110,502.)
Government Benefits: Advocates helped indigent seniors and the disabled, homeless veterans and working poor families secure CalWORKs, Social Security Supplemental Income (SSI), Medi-Cal, Medicare, Food Stamps, In Home Support Services (IHSS), General Relief, and Veterans' Benefits. Advocates were actively involved in shaping Los Angeles County's welfare reform plan and assuring its effectiveness in supporting low-income families. This program served 23,512 clients in 260 days.

4c (Code:) (Expenses \$ 2,221,677. including grants of \$) (Revenue \$ 117,002.)
Immigration: Advocates provided U.S. citizens, lawful permanent residents, refugees and asylum seekers with assistance in family reunification matters and helped battered immigrant women seek legal residency under the Violence Against Women Act. Advocates also helped torture survivors and victims of human trafficking access legal rights and benefits that have been afforded to them under federal legislation. This program served 24,731 clients in 260 days.
