The UFWF coordinated the national field campaign to engage farm workers to advocate for fair and just immigration policies.

4b (Code:) (Expenses \$ 259,826. including grants of \$) (Revenue \$)

In order to be prepared for the implementation of immigration reform once it is passed in Congress, the UFW Foundation is developing a national plan to ensure that farm workers from around the country have the proper information and resources needed to be able to receive legal status.

4c (Code:) (Expenses \$ 1,101. including grants of \$) (Revenue \$)

In January 2007, the UFW Foundation mobilized hundreds of farm workers to urge local, state, and federal officials to provide farm worker disaster relief caused by a citrus crop freeze that left 28,000 farm workers unemployed or working in other crops for lower pay. Over 8,296 Central Valley families benefited from 20 large food distributions. 2,000 signatures were collected and demonstrations to support federal disaster relief achieved \$1.75m in state and \$16m in federal disaster assistance. Minor costs were incurred in 2008 related to these activities.
