The Association's educational courses were utilized by more than 5000 members. The Association also offered a management certification program that contributes to greater professionalism within the rental housing and apartment industry. 700 members completed the certification program and are certified by the Association. The Association conducted an educational conference/trade show attended by 1,000 members.

The Association provides a comprehensive website that is a portal to vast library of association information. The CAA website had approximately 400,000 visits to its compliance pages.
