We operate five Ronald McDonald Houses in Southern California in Bakersfield, Loma Linda, Los Angeles, Orange County and Pasadena. In 2009, we served more than 12,500 people through the Ronald McDonald House program and provided more than 30,000 overnight stays for families with seriously ill children. In addition, more than 98% of our families indicated their stay at a Ronald McDonald House had a positive impact on them and their child’s recovery at a local pediatric hospital. We also made remarkable progress in 2009 toward opening a new Ronald McDonald House in Long Beach.

We served 1,839 campers at Camp Ronald McDonald for Good Times in 2009. The purpose of Camp is to build self-esteem and confidence in children who have been diagnosed with cancer and their siblings and families. We operate five week-long summer camp sessions per year along with several family and youth camp weekends throughout the year.

We awarded more than 140 scholarships and more than \$500,000 in grants to community agencies and hospitals that serve children in 2009. The scholarships will enable high school seniors to attend college by supporting \$2,000 in tuition for their first year of college. The grants are awarded through a competitive process which focuses on the broad geographic area we serve and on the impact being made on children in the community.
