We primarily work in the countries of Kosovo, Armenia, Ukraine, and Russia. Our vision is to bring the Gospel to all nations in accordance with the Great Commission of Matthew 28 with emphasis on the former Soviet Union and Eastern Bloc countries, using ministries of compassion to share our faith in both word and deed.

Strategy:

Our focus is on the younger generation, the two million "at-risk children" living in these regions who need assistance to become healthy well adjusted adults. We identify those at risk and design support programs together with church and ministry partners to assist young people in their development. We partner with in country Christian believers, local churches and NGOs', as well as social service agencies.

We design sponsorship ministries to allow sponsors to connect with individual children and their families; to connect with local pastors and missionaries who work with these children; and to connect with foster families who are adopting or raising orphans in their homes.

Mission Trip Teams:

Mission trips are organized and designed to assist and help develop mentoring relationships with at-risk youth. We run multiple youth camps for 1-2 weeks each summer and winter and encourage American young people to travel and learn how to relate of youth in other countries.

Raising Up Christian Foster Families:

We work to promote, recruit, and support Christian Foster Families to take in at-risk youth in their country and raise them as their own.

Support National Chaplains & Missionaries:

We support indigenous pastors and missionaries to work with at-risk youth year round as well as to visit adult and youth prisons to share the gospel of Christ.

Families received medical assistance in our Ukraine program. Families received monthly grocery vouchers in Kosovo. Families in Kosovo are made up entirely of widows and handicapped family members.

Benefits to families in all countries include personal visits with an EEO paid counselor / coordinator; and many families received extra support through the help of their sponsors in the United States.

**652 Children in Ukraine Child Sponsorship Program:**

Benefits to children include a Christian Camp experience to provide a fun and safe, loving environment. (in contrast to their home situations) Camps are staffed with EEO counselors and they place an emphasis on the spiritual development of children. Camp themes include character, integrity, courage, and honesty using biblical references and personal testimonies.

Children also receive Birthday Presents; Christmas Presents; exchange letters with sponsors; English classes, Computers training, families receive medical benefits and care, and they receive the care and attention of the our area child care coordinator.

**12 Families In Kosovo:**

Families in Kosovo are primarily widows or those with special needs such as mental illness, blindness, or emotional trauma. The Kosovo program is designed to provide basic food necessities for these very poor children and their families. Families are able to redeem grocery vouchers each month for 50 Euros (\$65) at a local grocery store partner.

**8 Pastors (Chaplains):**

All of our national pastors (chaplains) reside in different areas of Russia. These men also work part time to support their families and ministries. They are part of local Russian churches and use their financial sponsorship support to pay for expenses to travel and share Christ's love in adult prisons, in youth prisons, and with at-risk youth in orphanages. They receive \$150 per month support for their ministry.

**48 Student Scholarships:**

In Ukraine, an extension of the Child Sponsorship Program is the Student Scholarship program. Those young people showing Christian character, good grades, and who agree to monitoring and counsel from our EEO Student overseer, are eligible for a Student Scholarship of \$250-\$550 per semester depending on their level of higher education.

Foster Family Program:

In 2009 EEO continued to support and promote Ukrainian families to provide foster care for orphans and street children. As of Dec 31, 2009 there were 15 Foster Families receiving monthly financial support of \$200 per month. These families represent approximately 141 foster children who now live with families.

It is our goal to expand this ministry to Foster Families, which will in turn provide housing and a loving home for orphans in Ukraine.
