	<p>The Healthcare Foundation at GAMC provides a fund raising function to support the mission of Glendale Adventist Medical Center and programs to improve the quality of life and health in our community. The funds are transferred to the hospital based on the grantors and donors' intent. A significant portion of Management and General expenses are paid for by Glendale Adventist Medical Center and accounted for as a department of the hospital in its support of the Foundation. See the following selected information for Glendale Adventist Medical Center which are funded in part from the activities of the Healthcare Foundation at GAMC. Glendale Adventist Medical Center provides quality medical health care regardless of race, creed, sex, national origin, handicap, age, or ability to pay. Although reimbursement for services rendered is critical to the operation and stability of Glendale Adventist Medical Center, the organization recognizes that not all individuals possess the ability to pay for essential medical services. Adventist Health's vision is to enhance the health of the communities where we live and serve, by engaging our communities and our patients in a new definition of and partnership for personal community health. In keeping with this commitment to serve all members of the community, the following will be considered when individuals who need health care cannot pay: Providing free care and/or subsidized care; Providing care to persons covered by governmental programs at below cost; Providing health/wellness activities and community education programs. Not only does Glendale Adventist Medical Center provide low-cost care to individuals covered by government programs and those unable to afford health care, but it also helps patients find and access private and governmental resources for health care benefits. Glendale Adventist Medical Center recognizes below-cost reimbursement as charity and uncompensated care in meeting its mission to the entire community. The unreimbursed value of providing care to these patients in 2009 was \$34,033,231. Inpatient services in 2009 were provided to 18,485 patients. These services included: 2,562 Babies delivered; 3,740 Surgeries performed; 55,083 Radiology procedures performed; 32,734 Cardiac catheterizations and other procedures; 732,579 Laboratory tests performed; 537 Rehabilitation patients; 1,642 Mental health patients. Outpatient services in 2009 were provided to 268,188 patients. These services included: 40,589 Emergency room visits; 4,103 Outpatient surgeries performed; 62,420 Radiology procedures performed; 10,637 Cardiac catheterizations and other procedures; 421,429 Laboratory tests performed. Home Care services in 2009 were provided to 26,088 patients. These services included: 15,837 RN visits; 7,927 Physical Therapy visits; 1,238 Occupational Therapy visits. Glendale Adventist Medical Center recognizes it has an obligation to provide human services above and beyond its role as a healing facility. The following community benefits demonstrate the tangible ways in which the organization is fulfilling its mission: Children's Health Outreach Initiative; Center to Increase Community Organization; Community support groups; Community health education classes; HQ Newsletter for health promotion; Paramedic base station; Tobacco Control Program; Cancer Survivor Day; Beyond Loss bereavement program; Mental health support groups; Glendale Downtown Dash; Breast Cancer Awareness Month; Cancer Screenings &amp; Fitness Program.</p>
