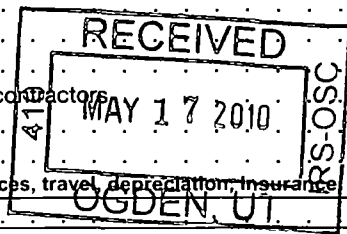

Geographic Mapping

GMI creates and delivers geographic mapping software, data sets, training, services, and consulting for the international evangelical missions community. During 2009 we:

- Published version 3.3 of the Global Ministry Mapping System, our flagship geographic information system (GIS) used by 270 Christian ministries in 39 countries to research, plan, coordinate and communicate their work.
- Updated and enhanced major geographic databases including the World Language Mapping System (mapping the world's 7,000 languages); the Seamless Digital Chart of the World; the Populated Places Database of 3.2 million cities, towns and villages; and the Omid database of the peoples, languages and religions of South Asia.
- Provided orientation, training, consulting and technical support for users of the Global Ministry Mapping System around the world.
- Enhanced our online mapping service through the Mission InfoBank website.
- Expanded our custom mapping service to design and create thematic maps to meet specific missions client needs.

Research and Information Publishing Services

GMI conducts collaborative research projects and client research, provides applied research training, and publishes and distributes research resources for the evangelical missions community. During 2009 we:

- Revised our Breakthrough research training curriculum and taught week-long seminars to 57 students.
- Continued our collaborative research efforts of best practices, cross-cultural sharing of funds in mission partnership, mission agency leadership and missionary candidates.
- Provided mission research CD-ROMs and books to 550 Christian leaders.
- Hosted and maintained three websites providing access to key information collections: MisLinks, Operation World and Mission InfoBank.
- Launched Phase 2 of the Mission InfoBank website development.
- Completed preliminary mapping and graphics work for two major new missions books: *Operation World* and *The Future of the Worldwide Church*.
- Contributed to international mission research and information publishing through a variety of speaking, writing and informal consulting opportunities.
