<p><b>28</b> Started a small grants program, funding 14 different local groups of activists, two groups got start up grants to help them print literature on water conservation, reducing waste, encouraging recycling. The water committee reached over 2000 children and their parents at local fairs, festivals and local events. Other grants went to preparing maps to identify habitat for endangered species and saving and restoring wildlife corridors.
