DCM offers supports to certain schools and organizations in East Asian Countries.

DCM seldom offers cash grants. A DCM executive travels to China, buys merchandise, service and supplies in China. The goods and supplies are then delivered to the organizations located in East Asian Countries. If there is any cash paid to the organizations, DCM executive would verify proper use of the funds during regular visits to the organization.

DCM maintains an one person agent office in Yanji city, China to support DCM's activities described previously. The person's salary as well as maintenance costs are sent to China. In 2009, the amount paid for that purpose was \$12,000. As DCM executive travels to China and East Asian Countries on a regular basis (5-6 times a year), the expenses used in the Yanji city office is reported and examined by the executive ensuring proper use of the fund.
