Family Well Being Program provides safety-net resources low income families, seniors and children in a dignified manner. We assist the community with their basic needs including food, clothing, enrichment, advocacy and medical referrals.

Pantry Program provided fresh groceries once a week to 1,001 unduplicated low income families and mentally or physically disabled three days per week and holiday baskets that allow families to enjoy nationwide traditions without the burden of an expensive feast. The Center was the primary source of food and nutrition for 62,824 persons whose diets otherwise would be significantly deficient.

Homeless Well Being Program provides practical resources relieving the day to day pain caused by homelessness; we offer meals, clothing, general medical services, mail services and various referral support services.

Soup Kitchen served a hot breakfast four days a week, 1 continental breakfast, 6 lunches to the homeless Monday through Saturday. St. Francis Center served the sick and the poor by providing 35,807 hot meals 10,327 continental breakfasts and 12,157 lunches prepared and served with the help of volunteers each day and solely by volunteers on Saturdays and holidays. We offer nourishment to fill the bodies and souls of our clients by giving them more than a warm meal; we provide

Youth Empowered for Success provides positive alternatives to negative youth activities such as gangs, violence, drugs and related delinquency offers year round activities for local youth.
