

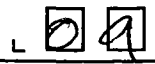

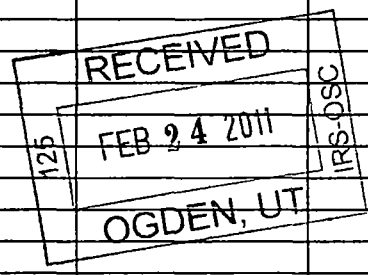

This return is being amended to correct over-reported capital gains on the original filing.

On the original return net losses from sales of securities were correctly reported on page 1, line 6a as (\$2,636,659). However, the bulk of these realized capital losses were erroneously excluded from page 2, Part IV, line 2, and consequently from page 1, line 7. Rather than the reported capital gain of \$363,846 the Foundation had realized net capital losses of \$2,636,659. While the loss is not deductible in the determination of Net Investment Income (line 27b), the gain reported on the original return is being amended to \$None.

The original return reported an overpayment of tax of \$201,219 which was applied to the 2010 estimated tax. The correct overpayment as per this amended return is \$208,496. The taxpayer requests that the additional overpayment of \$7,277 resulting from this amended return also be applied to the 2010 estimated tax.
