RESOLUTION OF THE BOARD OF TRUSTEES

AMENDMENT TO BYLAWS

RESOLVED, that the Bylaws of the Foundation be amended in the following manner:

Section 1 of Chapter 1 is deleted in its entirety and replaced with the following:

“The number of Trustees shall not exceed ten (10). The period of time during which any Trustee shall act as such (hereinafter referred to as his or her “Term”) shall be three (3) years from his or her election. Any Trustee whose Term thus expires, may however, be reappointed for a succeeding Term or Terms as hereinafter provided.”

Section 3 of Chapter 1 is deleted in its entirety and replaced with the following:

“All vacancies in the Board shall be filled by the affirmative vote of a majority of the Trustees, and filed with the original trust instrument, except that in case the Trustee to be replaced be a descendant or relative of Trustor, then the appointment of the successor Trustee shall be made in the same manner by the remaining Trustees who are descendants or relatives of WK Day.”

Section 5 of Chapter II is deleted in its entirety and replaced with the following:

“At all meetings of the Board a majority of the Trustees shall constitute a quorum, and the concurrence of a majority of the Board present at the meeting shall be necessary and sufficient for the transaction of any business.”

Section 1 of Chapter III is amended by adding the following sentence at the end of the paragraph:

“The Board may appoint such other officers with such other titles as the Board shall determine.”
