North Hawaii Community Hospital (the Hospital), located in Kamuela, Hawaii on the island of Hawaii, is a not-for-profit, acute-care hospital that provides inpatient, outpatient, and emergency care services for the residents and visitors of North Hawaii. The Hospital was chartered in November 1987 and commenced operations in May 1996. The Hospital is currently licensed for 39 beds. Admitting physicians are practitioners in the local area. In May 1996, Adventist Health System/West, Inc. was retained to manage the Hospital. Effective January 2008 the Hospital terminated its agreement with Adventist Health System/West, Inc. and retained Quorum Health Resources LLC (QHR) to manage the Hospital. Effective March 2010 the Hospital terminated its management agreement with QHR. Total outpatient visits for 2009 were 50,510. Total admissions for 2009 were 1,927.
