The Kauai Food Bank is the only charity on Kauai and Niihau that can warehouse mass quantities of food and distributes in manageable portions for agencies that feed the needy. Food is gathered from the community, local grocers, and from sources off-island and distributed to not for profit agencies and/or churches who give food directly to qualified individuals without charge. Kauai Food Bank leaders believe that the measurement of success in this mission is not achieved by feeding more and more hungry people, but to strive and eliminate the need for emergency food requests. Kauai Food Bank provides job training and skill building to needy individuals. Kauai Food Bank received the Employer of the Year Award, 2009, from the state of Hawaii, Department of Human Services, Division of Vocational Rehabilitation.

4b (Code) (Expenses \$ 46,617. including grants of \$ 44,421.) (Revenue \$ 44,421.)

The Keiki Cafe provides super-sized nutritious food products to children from the age of 7 - 17 at The Boys and Girls Club, Waimea Clubhouse. This was the fifth year of this program. Needy youth are provided after-school foods in a safe, structured environment and offered nutrition education, and other services.

The Backpack program provides nutritious food to needy youth at the Waimea Clubhouse and Kapaa Boys and Girls Club. All of which are packaged in unmarked backpacks and distributed each Friday for use over the weekend.

SNAP Outreach program conducts a formalized food stamp outreach that provides aid with pre-screening applications and assistance with documentation.
