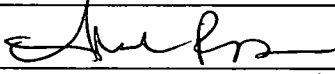
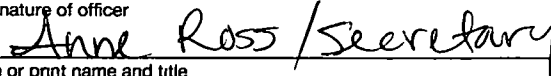

(a)

In 2009, we inaugurated our new baseball field and completed our first little league season. We had ten youth baseball teams which allowed over 150 children to participate in baseball, learning responsibility, discipline and character. The baseball field is encouraging wellness in the community by encouraging exercise & activity.

We had 87 people from 6 different mission teams come to conduct medical, dental and vision clinics, vacation bible school programs, construction projects and a baseball clinic in our community.

Approximately 5000 medical patients were treated by our medical providers. The sick and injured were cared for, teeth were extracted and eyeglasses were issued. A scholarship has been granted by our foundation to a local Dominican man for nursing school.

We had 450 children attending our bible programs. Over 16 children came to our house on a daily basis to receive after school education. We began an English teaching program in our education facility.
