LAST YEAR THE OUTBACK BOWL PAID A COMBINED \$6.4 MILLION TO THE SEC AND BIG TEN CONFERENCES. THE OUTBACK BOWL HAS PAID IN EXCESS OF \$80 MILLION OVER ITS BRIEF HISTORY TO NCAA MEMBER INSTITUTIONS. THE OUTBACK BOWL ASSUMES TREMENDOUS FINANCIAL RISK AND LIABILITY WITH ITS FINANCIAL GUARANTEES TO THE SCHOOLS.
