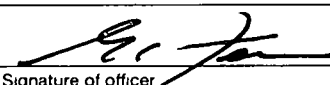

To that end, the executive management of the System and their support staff and systems will be centralized at LCMC. LCMC's activities will be exclusively limited to providing support services to the System. The revenue of LCMC will be derived from management fees received from the System Entities. LCMC will lease office space from Children's and pay rent to Children's at fair market value. While Children's and Touro are both tax exempt organizations, some of the affiliates and/or subsidiaries of Children's and Touro are for-profit entities. Any services provided to such entities will be at the express direction and for the benefit of Children's and Touro.
