The network is funded by NASA's National Space Grant College and Fellowship Program which was established by Congress in 1988 to contribute to the nation's science and engineering enterprise. Our mission is to - Improve our Affiliates research infrastructure in areas of mutual interest to NASA and the state of Maine, - Encourage more students to consider careers in fields of science, technology, engineering, and mathematics (STEM), and - Enhance NASA's presence throughout the State of Maine. Our Affiliates are undergraduate and graduate institutions, not-for-profit research laboratories, state agencies, technology-based businesses and science and education organizations, all of whom help further NASA's goals while benefiting Maine in many different areas of science and technology. We achieve our mission by competitively funding projects in four national objectives: Research Infrastructure, Higher Education, Pre-College and Public Service.
