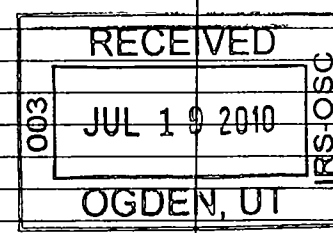

- A brief statement of the organization's purpose and goals.
- If applicable, a description of the project, the need and target population it addresses.
- Information about the capability of the leadership to implement the proposed project.
- Short- and long-term outcomes anticipated and plans for assessing achievements.
- Grant amount needed.
- A recent financial statement, audited if possible.
- A statement about the total agency budget and project budget, if different.
- A statement about other funding sources for the agency and/or project, specifying both committed and projected sources of support.

If you are requesting \$1000 or less, we may be able to evaluate your request based on the information contained in our letter of inquiry. However, you must also include a copy of your 501(c)(3) determination letter and a copy of our organization's current budget.
