BeadforLife provides work for beaders and tailors in Uganda who meet its membership requirements (they must be referred to BeadforLife from a partner organization and be living on less than \$2/day, as determined by home visit). BeadforLife pays its members fair trade prices up-front and creates a market for the jewelry and fabric items. BeadforLife pays fair trade prices to impoverished Ugandan women to collect shea nuts, which are then pressed into shea butter. BeadforLife is developing a line of shea butter products which will then be sold alongside its jewelry and fabric items. Volunteers host bead parties and community events where they sell the jewelry and fabric items, and educate worldwide citizens about the effects of extreme poverty.
