Young Heroes Foundation raised funds to support Young Heroes of Swaziland, a program of the non-profit National Emergency Response Council on HIV/AIDS of Swaziland, Africa, whose purpose is to feed and clothe those children, under the age of eighteen, who have been orphaned by the deaths of their parents due to the AIDS.

During the fiscal year ending March 31, 2010, funds provided by Young Heroes Foundation were used to provide food and clothing to 874 orphaned children in Swaziland. In addition, these funds also paid school fees for 24 orphaned children.
