Nurse Family Partnership is a nurse home visitation program that partners a specially trained nurse with a first time mom. The program begins in pregnancy and continues until the child turns two years old. The requirements for the program are first time mom before 28 weeks gestation and eligible for the Women, Infants and Children Program or Medical Assistance. This is a voluntary program. In March of 2010 York Nurse Family Partnership had its 9th anniversary. The program is staffed with 3-8 nurses and a full time supervisor. The program continues to see an average of 98 patients at any given point in time. In FY 09/10, 141 patients were served and 1,954 home visits were completed.
