Part VI, Line 19: Everyone involved in the organization is an unpaid volunteer. We sponsor and actively support a Boy Scout "ship" of Sea Scouts. We offer a sailboat training camp for children of members as well as the general public each summer. No Club member or Board Member is compensated in any way, so there is no written conflict of interest policy. The governing documents are the Constitution and By-Laws; they are published and a copy is provided to every member. Quarterly Financial Statements are provided to every member at each Quarterly Meeting, wherein every member is offered an opportunity to ask any questions. Additionally, a group of approximately 32 members, including the Board of Governors and all Committee Chairmen, are mailed Monthly Financial Statements. Additionally, any members who ask for a financial statement are provided it. Additionally, monthly meetings of the Board of Governors are open and any member may attend and ask questions. The fact that this Form 990 is posted in the public area of the Club House on a bulletin board, is publicized in the "Anchorline," the Club's monthly publication that is sent to all members and all non-member neighbors on Harbor Island, as well as to others in the Nashville sailing community.
