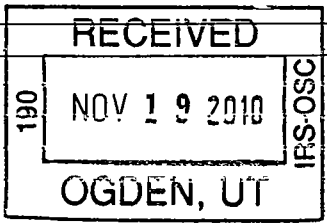

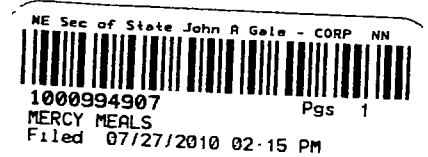

~~FIRST: The current name of the corporation is KIDS AGAINST HUNGER OF NORFOLK.~~


