The youth educational outreach program continued. Hundreds of middle school children visited the foundation for docent led tours emphasizing the surfing heritage being passed to them by those who have gone before them.

Continued significant progress has been made in the digital scanning and preservation of historical scrapbooks and both private and commercial photo collections. These digitized collections are to be available for research and educational purposes.

In addition to the permanent collection exhibits, traveling exhibits have also been developed for public viewing at local events such as the US Open of Surfing and various industry trade shows. The Foundation designed an extensive exhibit, a visual history of surfing's role in Orange County spanning the past 100 years. The exhibit was housed at the Orange County Airport for several months over last summer and was viewed by millions of travelers. An oral history coordinator to organize and continue the work of the committee in capturing oral histories of significant surf legends. He also digitized and archived existing material that had been collected in the past and was presented to Surfing Heritage for safe keeping.

Work continues on the web based virtual museum, which allows access to archived materials for educational and research purposes, to those unable to visit the Foundation in person.
