Client Services:

More than 7,000 contacts were made with clients in 2009. All services were free with the exception of a nominal fee for STD tests. These services included counseling women in crisis pregnancy situations, providing more than 2,100 pregnancy tests, performing 273 ultrasounds (183 lives were saved from abortion), providing pre-natal care instructions to expectant mothers, and performing testing for sexually transmitted diseases. The annual value of donated volunteer services in this area, which is not included in the program service totals, is approximately \$130,000.

Abstinence Education:

Our abstinence education curriculum, Willing to Wait, was taught in 51 schools to more than 5,000 students during the 2009 - 2010 school year. In addition, we presented the abstinence message to 1,250 community members. The annual value of donated volunteer services in this area, which is not included in the program service totals, is approximately \$55,000.

Family Support Services:

We distributed more than 89,000 material items to the economically disadvantaged including diapers, formula, baby clothing, cribs, car seats, etc. The annual value of donated volunteer services in this area, which is not included in program service totals, is approximately \$65,000.
