THE SENIOR EMPLOYMENT PROGRAM IS DESIGNED TO PROVIDE USEFUL PART-TIME OPPORTUNITIES IN COMMUNITY SERVICE EMPLOYMENT FOR LOW-INCOME PERSONS AGE 55 YEARS OR OLDER.
