### Part III – Statement of Program Accomplishments

A major focus of the Foundation's work this year was our Compassionate Assistance for Rape Emergencies (C A R E ) project. In connection with this, we:

- Developed a comprehensive list of all Missouri hospital emergency rooms and ER decision-makers. We received over a 60% response rate to our survey of state ERs. The survey results have given validity to our project, allowing us greater access to media and decision-makers. Because we found that over half of Missouri hospitals are not consistently providing EC onsite to rape victims, we have been able to make waves with our findings, gaining more volunteers and activists along the way, as more people grasp the shocking lack of EC access in our state.
- Sent 115 thoughtfully researched hospital information packets. These included position papers, EC fact sheets, resources on how to change hospital policies, informational flyers, copies of national recommendations from institutions like the AMA, and other helpful materials. Packets focused on developing this as an issue of compassionate care and expected medical protocol.
- Sent 115 follow-up letters and questionnaires to hospitals, asking for more information about their policies and offering our assistance in providing information, trainings, and resources for improving their policies.
- Created teams of activists and professionals from diverse fields who loaned their expertise to the project through helping publicize our results on social networking sites, writing Op-Ed's for local newspapers, inviting us to give presentations to their organizations, educating us about how this issue affects their work and lives, passing our petition along to friends and family, and allowing us to interview them for YouTube videos. We had at least 24 people on our C.A.R.E. "action teams," including five in Columbia/Jefferson City, four in Springfield, five in Kansas City, and ten in the greater St. Louis area.
- Led ten well-attended educational forums and presentations focused on EC in the ER. All of these talks were specifically "C A R E ." presentations, and altogether were attended by almost 300 people. All focused on the connections between violence against women and unintended pregnancy, what EC really is, how to access EC, what our survey results demonstrate, what lack of EC access means for rape survivors in Missouri, and what we can all do to improve hospital EC access. Five of these presentations were conducted on college campuses (as this information is especially relevant for college women, who are more likely to need EC and more likely to be sexually assaulted than other women), two of which were given in conjunction with a professor to a 300-level women's health class. Three of the presentations were EC trainings specifically addressing Sexual Assault Nurse Examiners in the Springfield area. One of those trainings was conducted at St. John's Hospital (a Catholic institution) and

was the first-ever EC training for nurses in the area. Another presentation was given specifically to the advocates on staff at the Missouri Coalition Against Domestic and Sexual Violence in Jefferson City, which allowed us to build a very helpful information-sharing relationship with them. We also participated in RAINN Day and Feminist Awareness Week at Washington University, presenting information to professors, fellow advocates, and interested student groups. Finally, one of our best-attended events was held at the Ethical Society of Mid-Rivers in one of the collar communities of St. Louis, which allowed us to reach activists not typically involved in NARAL activities, mobilizing them to join our CAN and volunteer lists to stay updated.

- Spread the word about lack of EC access for rape victims through our interactive, online petition. We collected over 300 petition signatures online, and at least 100 more on paper. As part of the interactive petition, signers could leave comments and personal stories with their signatures. Many of the petition-signers told stories about themselves or friends having experienced sexual assault without being given EC afterwards. We were then able to share those stories with newspaper editorial boards and hospital decision-makers in an attempt to put a personal face to the issue.
- Submitted three different radio PSA copies to 10-15 radio stations around Missouri at various times throughout the year. PSA's focused on distinguishing EC from RU-486 and encouraging listeners to stock up before they need it. At least one radio station in Mid-Missouri read our "EC Anniversary" PSA on air. Additionally, one of our clergy "action team" members discussed our C.A.R.E. project when she was interviewed on an independent radio show.
- Facilitated the publication of an editorial (which supported our EC in the ER position and cited our research) in the most widely circulated newspaper in Missouri, the *St. Louis Post-Dispatch*. A minister at a prominent Episcopal church in St. Louis accompanied us to the editorial board meeting, sharing her perspective on the issue and helping to place it in the framework of compassion and ethics. As a volunteer with a faith-based counseling group, she was also able to share personal stories about women seeking abortions and how they could have avoided the situation if they had had knowledge of EC. The editorial was published the week after our meeting with the newspaper, and received a great deal of attention in the St. Louis area from other reproductive rights organizations and activists.
- Submitted two Op-Ed's to Missouri newspapers from different clergy "action team" members in Springfield and Columbia.
- Reached thousands of activists through email alerts highlighting the terrible statistics found through our research and asking them to join our "action teams."
- Printed thousands of our glossy flyers throughout the past year, which have been distributed at various tabling events and other educational forums. The Ethical Society of Mid-Rivers plans to distribute them to their membership throughout the year. The Missouri Coalition Against Domestic Violence put them up in their offices. Other activists agreed to put them up at their favorite coffee shops and bulletin boards around town. Sexual Assault Nurse Examiners in Springfield decided to post them on the inside of the medicine cabinets in the examination rooms of their hospitals. By displaying these eye-catching flyers in diverse locations throughout the state, we are reaching average people well beyond our usual activist base and making an immeasurable improvement to the average person's knowledge of EC.

- Gave student activists glossy flyers with which to “flood” their campuses after each educational forum. Each student was designated an area of campus in which to post as many flyers as possible, strategically selecting areas with high traffic, as well as living spaces. Over 500 flyers were distributed this way, making an incalculable educational impact on students who walked by them daily and were not previously aware what EC is or how it works. The colorful and cleverly informative flyers received excellent feedback from college students. Additionally, the Student Forum on Sexuality at Washington University, which produces the very popular X-Magazine, printed our flyers as two full pages in their 2010 edition.
- Designed a Facebook “page” for EC in the ER that gained well over 300 “fans” and “friends.” The EC in the ER page is continually updated with news about EC and with event alerts related to the C.A.R.E. project. Many of our “friends” and “fans” post comments and responses to our updates. This page is an excellent tool for keeping activists updated on the work that we’re doing as well as for gaining public support and momentum for the project.
- Participated in a radio interview about barriers to access to EC in Missouri and the lack of access to EC in the ER.
- Published three YouTube videos showing various different “faces” of EC in the ER. One video features an emergency room nurse in Springfield talking about her experiences working within the hospital bureaucracy to make EC available to sexual assault victims. This video is critical for the project, as it gives voice to a true EC in the ER champion who would not stop until she made EC available to all rape victims who came into her emergency room. The second video is a series of short interviews with five student activists at Washington University, all of whom are involved with the Committee Organized for Rape Education. The interviews all take place as they are preparing to march in Take Back the Night. The third video features the experiences of a Sexual Assault Response Team volunteer, who takes the viewer through standard hospital protocol when a victim presents in an emergency room, what the rape kit entails, what the victim might be going through, and how to best support a victim. Not only does this video educate viewers on basic survivor-support skills, but it also emphasizes the jarring and often re-traumatizing experience of a rape kit and argues that EC should be included as part of rape kit procedure.

We also maintained our focus on preventing unwanted pregnancies through advocating access to EC and providing legal and policy arguments against regulations allowing pharmacists to refuse to dispense EC. We educated our members and the public about a proposed “personhood” ballot initiative. We maintained our clinic escort program, which we have operated since the 1980s.
