	West River Health Services (WRHS) is a nationally-recognized rural health care delivery system including hospital, swing bed, surgery, lab, radiology, emergency room, seven clinics, eye clinic, visiting nurse services, ambulance service, family therapy, rehabilitative therapies including physical therapy, occupational therapy and speech therapy, home medical equipment store, and wellness/fitness services In FY 2010, WRHS provided acute care services to 982 patients for a total of 3,703 days of care Swing bed services were provided to 149 patients for a total of 1,077 days of care In addition, 691 days of observation care were provided There were 1,733 emergency room visits during the year Ninety-eight babies were born during the year with a total of 239 days of care provided There were a total of 999 surgical cases during the year, with 802 of those being done on an outpatient basis The ambulance crew made 290 ambulance runs/transfers throughout the year There were 44,838 clinic encounters to the seven clinics Ancillary services were provided as follows 205,080 lab tests, 12,776 radiology tests, 8,284 respiratory therapy tests, 41,559 meals to patients, visitors, and employees, and 12,013 therapy visits Throughout the year, there were 1,802 RHC nurse visits It is the policy of the WRHS to provide quality health care services to all patients in the region regardless of race, color, creed or ability to pay To this end, WRHS offers free and discounted services to patients who lack ability to pay The WRHS Charity Care Policy, initially approved in June of 2006 and revised in 2007, assures that all eligible patients will receive the care they deserve without financial worry The Finance Committee of the Board of Directors has oversight of the Charity Care Program, approves eligibility criteria, and evaluates program effectiveness The amount of charity care provided in FY '10 for eligible individuals was \$183,120 These amounts reflect the amount of charges foregone based on established rates In addition to total uncompensated care for FY '10 of \$942,447, WRHS also provides many other services as in-kind support to benefit the health of the communities and region it serves These community benefits include conducting health screenings at all area farm and home shows, offering CPR and first aid programs to the general public, organizing/conducting an annual Fun Run & Walk during the 4th of July celebration, providing free educational pamphlets and brochures on various health topics to the general public, guiding tours of the hospital/clinic to area school children, providing health and wellness education classes to the public, assisting seniors/elderly to enroll and take part in medication assistance programs, educating/training paramedics/EMTs in all outreach communities, maintaining a health resource library for the general public, sending The Reporter (to inform on health-related issues and to update on educational meetings) quarterly to 12,000 households, and maintaining a fitness center for the public
