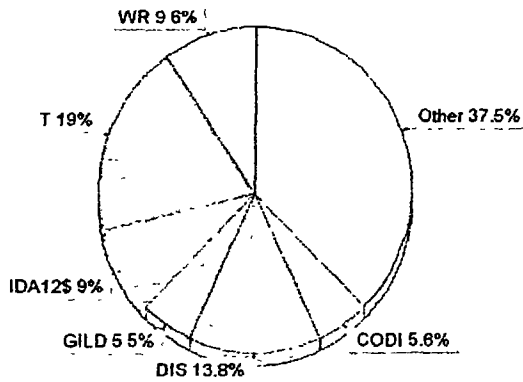

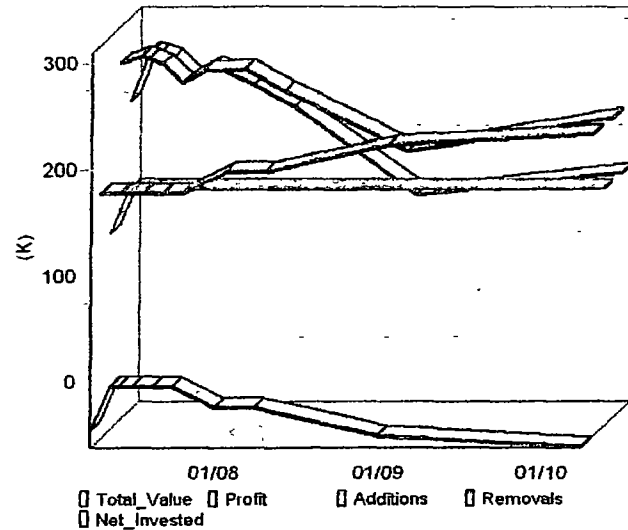
Holdings (by Type)
