Seconds Unlimited enhances community awareness of the Hospital's programs and services and builds Hospital support within the surrounding community, while serving the community with desirable goods at affordable prices.

Indigent Fund (The Elizabeth Barnhardt Sanders Fund). In May 2008, the RGH Foundation received a \$250,000 bequest from Mrs. Sanders, establishing an endowment to help indigent patients from Lancaster and Middlesex Counties. Distributions of the interest earned on the fund are used to support indigent patients from those geographical areas.
