The Foundation provided \$87,490 for Orthopaedic Surgery Equipment for Thomas Hospital this year. The equipment will benefit the majority of orthopaedic patients as it takes less time to complete many surgeries. Less time to complete the surgery means less time the patient is under anesthesia. The resulting faster turn over of the operating rooms result in less waiting time for patients and their families. In addition, various small grants totaling \$50,357 were made to the hospital for projects including the Pediatric Unit of the hospital, Diabetes Education, the Cardiac Care Unit, Mental Health Assistance, the Emergency Assistance Fund and the Employee Crisis Fund.
